MOTION by Josh Bell to approve minutes of previous meeting; seconded by Todd Bird and passed.

Treasurer's Report (Todd Bird)

Todd Bird sent a report showing the organization's current bank balance as of 10/13/20 and the statement from 9/30/20. The current balance is \$37, 601.17. After payment of outstanding invoices to Natalie Mataya, the Coalition for Adult Basic Education (COABE) and Mountain Plains Adult Education Association (MPAEA), AEAUT has \$34, 251.17. Cash awards still need to be paid and Todd is awaiting any additional invoices. He expects no further revenues. Cathleen Carter commented that AccelEvents has been slow to invoice the organization for their services in hosting the conference. Cathleen is expecting a discounted fee due to poor technical support. She will call Todd when she hears from AccelEvents. Kathryn Reeve inquired after vendor revenues: she wants to know if they were all received. She asked Danielle Pedersen to text Natalie Mataya and check. No response was received during the meeting.


New Business

- Board Transitions (Cathleen Carter)

The AEAUT Board welcomes new members Nicky Wake, starting this month, and Shauna Brown, starting next month. Based on post-conference surveys, 10-11 more people have expressed an interest in participating on either the board or one of the committees. The board also acknowledged the service of Mitch Peterson and Todd Bird. Cathleen Carter will be AEAUT President as of 10/31/20 and Mark Mataya will be Past President. A new Treasurer and a President-Elect must be found. No one present stepped forward or had suggestions.

<u>-Potential merger of Advocacy Committee and PR Committee to create "Awareness</u> Committee" (Josh Bell)

Josh Bell and Mitch Peterson, prior to his departure from the Board, suggested merging these two committees. The idea took root upon Josh meeting with Laurie Kierstead-Joseph, Region 5 Rep from COABE, who has been mentoring him. Josh suggests that merging the two committees will foster a more robust legislative response, promoting events related to Day on the Hill and other awareness.

Josh stressed the importance of Adult Education's presence during the next legislative session, since there is potential for budget reductions due to COVID19. Cathleen Carter will consult the AEAUT Constitution to determine whether restructuring the committees would require a motion or an amendment. She asked Josh to address the latest developments on Day on the Hill at the next Board meeting. Josh said he is ready to proceed with preparations, and was waiting until the Fall Conference had wrapped up before moving ahead. He is not sure what activities will be permitted during the 2021 session, due to COVID19 restrictions. Danielle Pedersen told the group that COABE had recently done a virtual tour of Pima Community College in Tucson, AZ, highlighting stories of the students there. Such a video might be useful in offering legislators a virtual tour of one of our programs here in Utah if we cannot have an in-person presence at the Capitol. Cathleen mentioned that in her conversation with State Representative Carol Spackman Moss, she was reminded the Utah State Senator Kathleen Riebe could be very helpful to AEAUT. (Action Item): Cathleen will reach out to her and text Josh after she does so.

Danielle Pedersen informed that Board that there has not been much interest shown in the training for the Student Ambassador Program at this point. This is probably because teachers are overwhelmed in dealing with COVID19. This training will be delayed until spring.
